## RESOLUTION 2020-005

### A RESOLUTION OF THE CITY TO BE LEGAL LOCAL GOVERNMENT SPONSOR FOR MINNESOTA DEPARTMENT OF NATURAL RESOURCES GRANT-IN-AID PROGRAM FOR THE CITY OF TOWER/HOWARD WAGONER SKI TRAILS

WHEREAS, the City of Tower has set-aside a portion of its Gundersen Forest lands for recreation; and

WHEREAS, volunteer groups have established, constructed and maintain public cross-country ski trails known as the City of Tower/Howard Wagoner Ski Trails, on this land for decades; and

WHEREAS, the Wagoner Trails Club (hereinafter after "Club") currently physically performs the work necessary in maintaining the trails and the Club completes tasks in a timely manner and submits documentation and program forms to the sponsor as required for sponsor to certify completion of significant benchmarks; and

WHEREAS, the Minnesota Cross-Country Ski Trail Grant-in-Aid Program provides grants to local units of government for the maintenance and grooming of recreational trails pursuant to Minnesota Statutes, Chapter 85.44 and 84.026; and

WHEREAS, this funding requires a local unit of government sponsor; and

WHEREAS, this funding is essential to maintain this recreational amenity for our residents and visitors; and

**NOW THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF TOWER, MINNESOTA** as follows:

1. The City of Tower will be the local government sponsor for the Club's City of Tower/Howard Wagoner Ski Trail Grant-In-Aid program funds for as long as this program exists and for as long as the Minnesota Department of Natural Resources will accept this resolution as valid.
2. The City of Tower will comply with all applicable laws, environmental requirements and regulations as stated in the annual State of Minnesota Grant Contract Agreement: Cross-Country Ski Grant-in-Aid-Program Maintenance and Grooming Grants; and
3. City Council of the City of Tower names the fiscal agent for the City of Tower for this project as:
