A RESOLUTION TRANSFERRING THE MONEY MARKET BANK ACCOUNT FOR THE COMMERCIAL REHABILITATION FUND (303) TO THE TOWER ECONOMIC DEVELOPMENT AUTHORITY

- WHEREAS,** the City Charter at Section 7.08 controls the maintenance of the City treasury General Fund and other funds; and
- WHEREAS,** the City or the Tower Economic Development Authority received monies from federal Community Development Block Grants and the IRRRB to create a Commercial Rehabilitation Fund, often referred to as a Storefront Loan fund or program; and
- WHEREAS,** the City opened a bank account in January 18, 1997 for this purpose; and
- WHEREAS,** the City of Tower Resolution 1996-10 established for the Tower Economic Development Authority in that Enabling Resolution; and
- WHEREAS,** the Minnesota Statute 469.094 Subd 2. Permits a city to, by resolution, transfer control over the operation of any project of this nature to the Economic Development Authority located within in the city; and
- WHEREAS,** the Commercial Rehabilitation Fund aligns entirely with the purpose for which Resolution 1996-10 was passed; and

NOW THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF TOWER, MINNESOTA as follows:

1. To transfer the Commercial Rehabilitation (303) from the City to the Tower Economic Development Authority.
2. The signers of this bank account will be the same as other Tower Economic Development Authority bank accounts.
