Correspondence was received from Brenda Broten regarding TEDA Funding and Procedures. No council action was taken.

Written reports were received from the Maintenance Department, Ambulance Department, Fire Department, Emergency Management, and Police Department.

A motion was made by Hiltunen and supported by Carlson to approve the reports from officers. The motion carried unanimously.

A motion was made by Hiltunen and supported by Carlson to adopt a resolution that states:

Whereas, the Highway 169 North Task Force was formed in July of 2000;

Whereas, the Highway 169 North Task Force has contributed to many improvements on Trunk Highway 169 over the last twelve years;

Whereas, the Highway 169 North Task Force has made recommendations to the Minnesota Department of Transportation for Highway Safety Improvements in the Eagles Nest Project Area of Trunk Highway 169, between Tower and Ely;

Now therefore be it resolved, that the City Council of the City of Tower, Minnesota, does hereby adopt this resolution in support of the Highway 169 North Task Force recommendations to the Minnesota Department of Transportation for these Highway Safety Improvements. The motion carried unanimously.

A motion was made by Carlson and supported by Hiltunen to hire Travis Benck and Erick Bjorgo as summer helpers for the 2013 Summer Season. The motion carried unanimously.

A motion was made by Hiltunen and supported by Abrahamson authorizing sixteen hours of Summer Help support to the Harbor Committee for event clean up and oversight. Mayor Abrahamson and Councilor Hiltunen assented and Councilors Dougherty and Carlson dissented. The motion failed.

A motion was made by Councilor Carlson and supported by Hiltunen to pay all bills. The motion carried unanimously.
